- (iii) How to prepare the quotations/financial bids: The quotations may be sent for the gross weight as per the proforma. The format of the proforma is explained as below: The column "packing charges per 100 kgs" shows the unit cost for the total packing. The second column shows the cost towards the container/liftvan and packing material and the third column towards labor. Thus the

figure in the 1st column should be the corresponding fraction of the sum of 2nd and 3rd columns.

- (iv) Packing Rates should be valid for one year from the date of agreement
- (v) The packing material including all required items to be used should be of the international standards.
- (vi) In case of "By Ship" mode of consignment, quotation (as and when requested) should include the charges for inland haulage of the container from the concerned port of the residence of the High Commission staff in Mbabane, ocean freight (subject to actual charges by the shipping company to be supported by documents along with invoices) from Mbabane to India and handling charges in . All documents and customs formalities are also required to be completed by the packers/forwarders. You will also require arranging insurance coverage of the personal effects to the value as advised to you from time to time.
- (vii) In addition to the dispatch of the consignment from Eswaini, you may also be required to process the release of incoming shipment of the similar weight-slabs arriving by Sea and Air Cargo and transported to the residence of the High Commission staff in Eswatini after completing all the documentation and custom formalities. You will be required to intimate all the inclusive rates for about slab of weights (as and when requested). The minimum charges for release of incoming shipment consignment by Ship as well as by Air cargo may also be included in the quotation.
